The governing body gathered in the Bulldog Board Room located in Walker Dining Hall on the Corsicana Campus at 10 a.m. on Tuesday, September 10, 2024 to conduct a public hearing on the intent to set the 2024 (FY 2024-2025) Ad Valorem tax rate. Chairman Phil Judson started the meeting with a prayer. The meeting was called to order at 10 a.m. in the Bulldog Board Room. He announced the purpose of the meeting is to conduct a public hearing on the governing body's intent to set the Ad Valorem Tax Rate for Calendar Year 2024 (Fiscal Year 2024-2025) at the current rate at \$0.0968 per \$100 of taxable value. The proposed tax rate exceeds the No-New Revenue Rate but does not exceed the Voter-Approval Rate as prescribed by Tax Code 26.06(b-2). In accordance with Tax Code statutes, a notice was published in the Corsicana Daily Sun and this public hearing was scheduled to hear comments from any Navarro County community members on the Board's intent.

Chairman Phil Judson opened the Public Hearing and asked if anyone wished to address the Board.
There were no requests to address the Board.

Chairman Phil Judson asked for a motion to close the Public Hearing.
Trustee Kim Wyatt made a motion to close the Public Hearing and was second by Trustee A.L. Atkeisson.

Chairman Phil Judson stated that a record vote is required by the Board to set the 2024 (FY2024-2025) Ad Valorem Tax Rate of \$0.0968 per \$100 taxable value.

Chairman Phil Judson asked each Board Member for their vote.

After the record vote Chairman Judson asked for a motion to adopt the Ad Valorem Tax Rate of \$0.0968 per \$100 taxable value.

I Trustee Richard Aldama move that the property tax rate be increased by the adoption of a tax rate of \$0.0968 which is effectively an 8.28 percent increase in the tax rate and second by Trustee Faith Boyd.
